DEFYING THE MUSLIM BROTHERHOOD IN AMERICA'S HEARTLAND

Standing up to Omaha's "Tri-Faith Initiative"

Omaha, NE 1BSeptember 9, 2014– Omaha Nebraska's <u>Tri-Faith Initiative</u> is a project that intends to co-locate a Synagogue, a Church and a Mosque on the same physical campus. The project has become a darling of the progressive Left, and has the support of a number of well-known names, such as the <u>Buffett</u> family and the <u>Kiewit</u> Foundation, as well as a host of other well-connected individuals and organizations of national note.

It has also spawned very reasonable suspicions regarding the involvement of two groups known to the FBI as <u>front operations</u> for the Muslim Brotherhood in America. Dr. Mark Christian, the Executive Director of the <u>Global Faith Institute</u>, and an Omahabased writer, Mr. Joe Herring, discovered links between CAIR, the Council on American Islamic Relations and ISNA, the Islamic Society of North America with the Tri-Faith Initiative's <u>Muslim component</u>.

Their oft-repeated request for the project organizers to disavow further involvement with these terror-linked organizations has thus far fallen on deaf ears. However, Dr. Christian has been threatened with a <u>lawsuit</u> if he continues to ask this very reasonable question; "What possible benefit do these two groups (<u>CAIR & ISNA</u>) provide to the Tri-Faith Initiative that can ever outweigh the <u>bloody baggage</u> that travels with them?"

Dr. Christian and Mr. Herring have continued to pursue the answer to this question despite threats of both a legal and physical nature. Their investigation has produced <u>multiple articles</u> and is drawing <u>national attention</u> to the use of "interfaith" efforts to mainstream radical Islamist teachings.

It is the belief of both Mr. Herring and Dr. Christian, that by defying the Muslim Brotherhood in the heartland of America and halting their interfaith charade in Omaha Nebraska, a precedent can be set for dismantling the educational, political and pseudoreligious influence of the Muslim Brotherhood in our schools, houses of worship and government.
